

Automatic Systems ("AS") solutions use a thermographic camera installed in its turnstiles and access control systems (the "Equipment") designed to detect skin-surface temperatures and determine whether face masks are being worn. The purpose of the Equipment is to achieve rapid preliminary screening and detection in public areas. The following information should be reviewed carefully when considering whether to purchase and install the Equipment.

- ii. A person's actual core body temperature may not be properly detected by the thermographic camera due to measurement tolerances, and should be independently confirmed by using clinical measurement devices
